SPECIAL VEHICLE RULES AND REGULATIONS

A Special Vehicle Permit must be issued **prior** to operating a special vehicle on City Streets. Proof of Insurance Coverage for Operation on City Streets must be provided at time of permit purchase. The Special Vehicle Permit must be renewed annually. **Operators are required to obey all Minnesota Traffic Laws and use hand signals.**

Special vehicles are **permissible** on streets, and designated sidewalks and trails (pictured below) provided that:

- City of Howard Lake Special Vehicle permit sticker displayed on the rear of vehicle
- Operator possesses valid driver's license.
- ATV operators ages 15-17 possess ATV Safety Certification
- Verification of insurance coverage must be carried at all times
- Slow moving vehicle emblem displayed on rear of golfcart
- Vehicle is equipped with rear view mirror
- Number of passengers limited to seating capacity
- Vehicle is driven on the far right side of the road except when making a left turn
- Vehicles operating on designated trails yield to pedestrians and cyclists



Special Vehicles are **prohibited** from:

- Operating on state or federal highways, except to cross at designated intersections. This applies to County Road 6, County Road 7, and State Highway 12.
- Operating during inclement weather or limited visibility
- Operating between sunset and sunrise; unless equipped with original equipment headlights, taillights, and rear facing brake lights.
- Exceeding speeds of 20 miles per hour
