Traffic Regulation In The City Of Howard Lake

- **Section 1. Highway Traffic Regulation Act Incorporated by Reference.** The regulatory provisions of the Minnesota Statutes Annotated 1967, Chapter 169, as amended, are hereby adopted as Traffic Ordinances regulating the use of highways, streets and alleys within the City of Howard Lake, and are hereby incorporated in and made a part of this Ordinance as completely as if set out here in full.
- **Section 2. Safety Responsibility Act Incorporated by Reference.** The regulatory provisions of Minnesota Statutes Annotated, Chapter 170, as amended, are hereby adopted as an Ordinance regulating financial responsibility of drivers of motor vehicles used on the highways, streets and alleys within the City of Howard Lake, and are hereby incorporated in and made a part of this Ordinance as completely as if set out here in full.
- **Section 3. Driver License Law Incorporated by Reference**. The regulatory provisions of the Minnesota Statutes Annotated, Chapter 171, as amended, are hereby adopted as an Ordinance regulating licenses and permits of drivers of motor vehicles used on the highways, streets and alleys within the City of Howard Lake, and are hereby incorporated in and made a part of this Ordinance as completely as if set out here in full.
- **Section 4. Snowmobile Act Incorporated by Reference.** The regulatory provisions of the Minnesota Statutes Annotated, Sections 84.81 through 84.81, as amended, are hereby adopted as an ordinance regulating the registration, operation and use of snowmobiles within the City of Howard Lake, and are hereby incorporated in and made a part of this Ordinance as completely as if set out here in full.
- **Section 5. Motor Vehicle Transportation for Hire Act Incorporated by Reference.** The regulatory provisions of the Minnesota Statutes Annotated, Chapter 221, as amended, are hereby adopted as an Ordinance regulating motor vehicles transporting for hire, common carriers and contract carriers within the City of Howard Lake, and are hereby incorporated in and made a part of this Ordinance as completely as if set out here in full.
- Section 6. Motor Vehicle Registration, Title and Tax Act Incorporated by Reference. The regulatory provisions of the Minnesota Statutes Annotated, Chapter 168, as amended, are hereby adopted as an Ordinance regulating the registration, title and taxation of motor vehicles within the City of Howard Lake, and are hereby incorporated in and made part of this Ordinance as completely as if set out here in full.
- **Section 7.** Whenever applicable, the word "Chief of Police" shall be substituted for "Commissioner" or "Commissioner of Highways" in the above adopted statutes.
- **Section 8. Revisor's Bill, Misdemeanors and Penalty Act Incorporated by Reference.** The regulatory provisions of the Minnesota Statutes Annotated, as amended by Chapter 23 of the 1971 Regular Session Laws of the Legislature of the State of Minnesota and other amendments, are hereby adopted as an Ordinance regulating and prescribing the penalty for certain petty

misdemeanors, and are hereby incorporated in and made a part of this Ordinance as completely as if set out here in full.

Section 9. Penalty. Any person convicted of violating any provision of this ordinance is guilty of a misdemeanor.
