2023 is expected to be a big year for Howard Lake!

The coming year is already looking to be a very busy, big year for our small town. Here's a quick rundown of some new projects and initiatives the City of Howard Lake is undertaking in 2023.

Howard Lake Foods, shuttered since July is currently being considered by several potential operators who would re-open the store. The two most interested entities each have their own niche they would seek to fill. One is considering subdividing the store to accommodate a convenience grocery store with the option of a second retail tenant. The other entity is considering a membership based grocery store which would permit 24/7 access. Both entities are

expected to provide the City with various information to help form how we move forward towards a hopeful reopening.

Terning Trails, located on the northeast of the lake off of 1st Street East, is expected to see additional development this year with the proposed addition of a 30 unit, market-rate apartment complex as well as a 100 slot childcare center slated to be built alongside the Good Samaritan Society Assisted Living Center. Both projects have been identified goals by the City for nearly a decade. Seeing these projects through to completion involves a strong partnership between private business owners and the City. Housing and childcare shortages are noted by large employers as barriers to attracting and retaining employees. Both projects are anticipated to receive various approvals in the next several months with ground breaking in the spring.

The State of Minnesota Department of Health Mandatory Service Line Inventory

The Minnesota Department of Health has passed a law requiring Minnesota Cities to complete a water service line inventory of all properties by 2024. The purpose of this rule is to identify any and all lead service lines inside homes and businesses. Prolonged exposure to lead may lead to detrimental health impacts or birth defects.

To do this, we are asking homeowners to send the City information about the water service line entering their home.


- Provide the City of Howard Lake a clear picture of the service line and the first valve prior to your water meter (preferably showing the side of the water valve). Be sure the picture also includes the floor, foundation, or ground in which the service makes its entry from the ground.
- If the service water line has paint, corrosion, etc., please scrape or remove such items for clear identification of the service line material prior to taking the picture.
- If material of the service line looks gray or dark gray, please use a magnet on a cleaned section of the service line. If a magnet sticks to the service line, please show this in your picture.
